





Boards to be fixed at 150mm centres to allow for 50mm spacing gap between adjacent boards.
2700mm long softwood timber post (100 x 100)
190mm long x 100mm wide x 22mm thick featheredge boarding to both sides. Boards to be staggered on each side.
100 x 50 bevelled softwood timber rails with bevel running away from boards towards posts. Rails to be fixed between posts.

Proposed 1.8m high treated hit and miss timber fencing or horizontal lat timber fencing. (not to scale)



900MM ESTATE FENCE

Boards to be fixed at 150mm centres to allow for 50mm spacing gap between adjacent boards.

190mm long x 100mm wide x 22mm thick featheredge boarding to both sides. Boards to be staggered on each side. Cut to stone wall to front.
