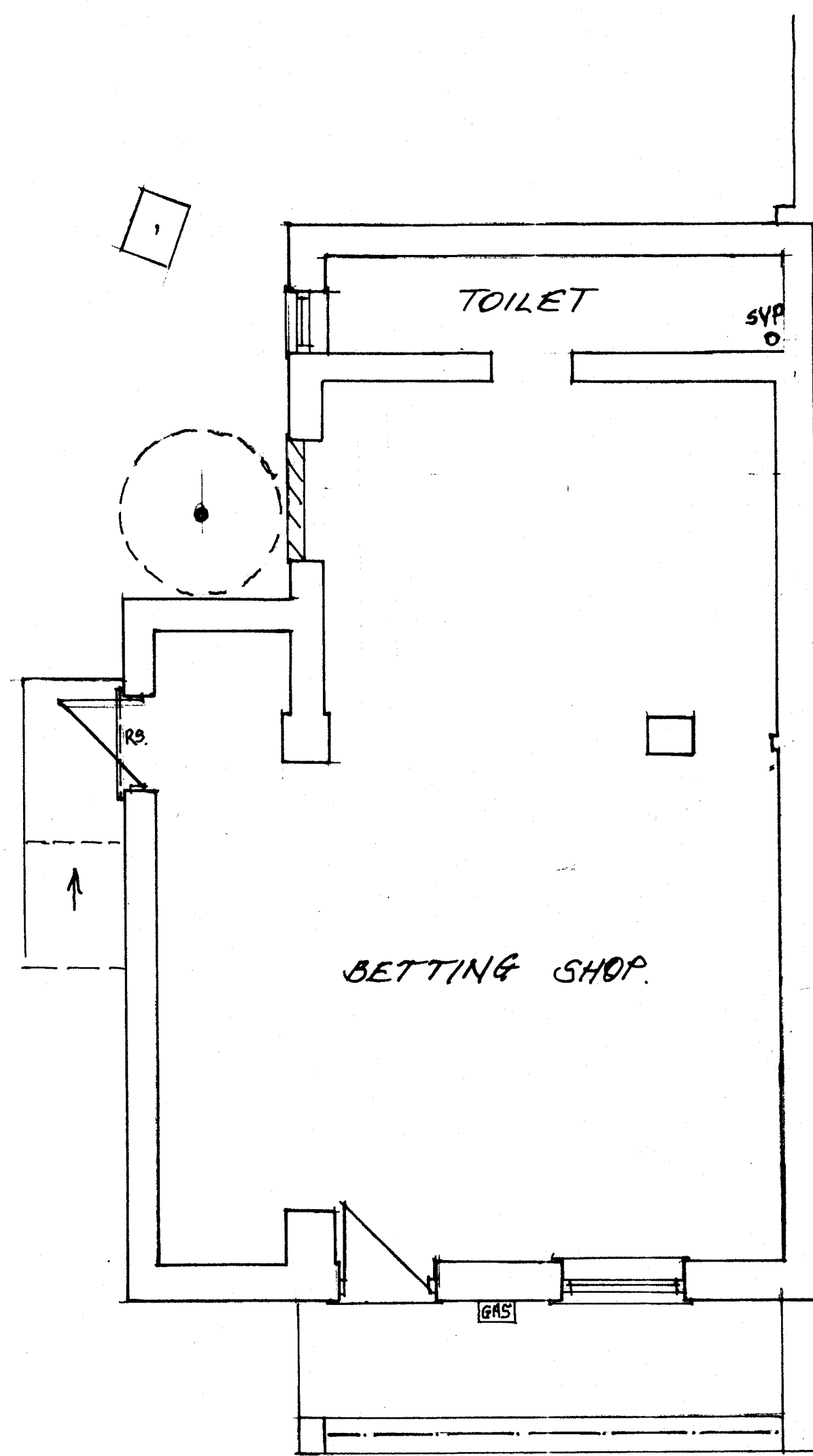
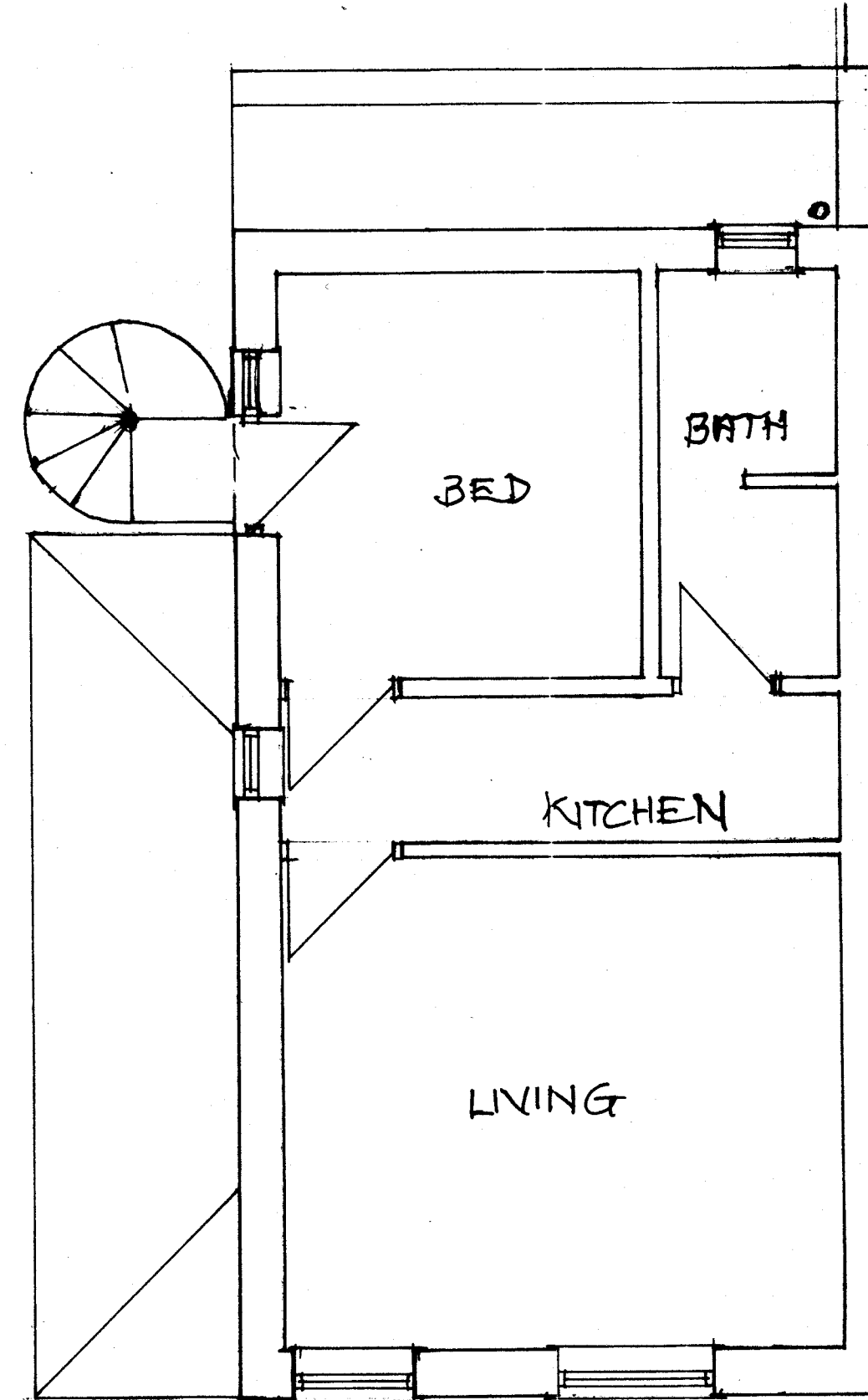
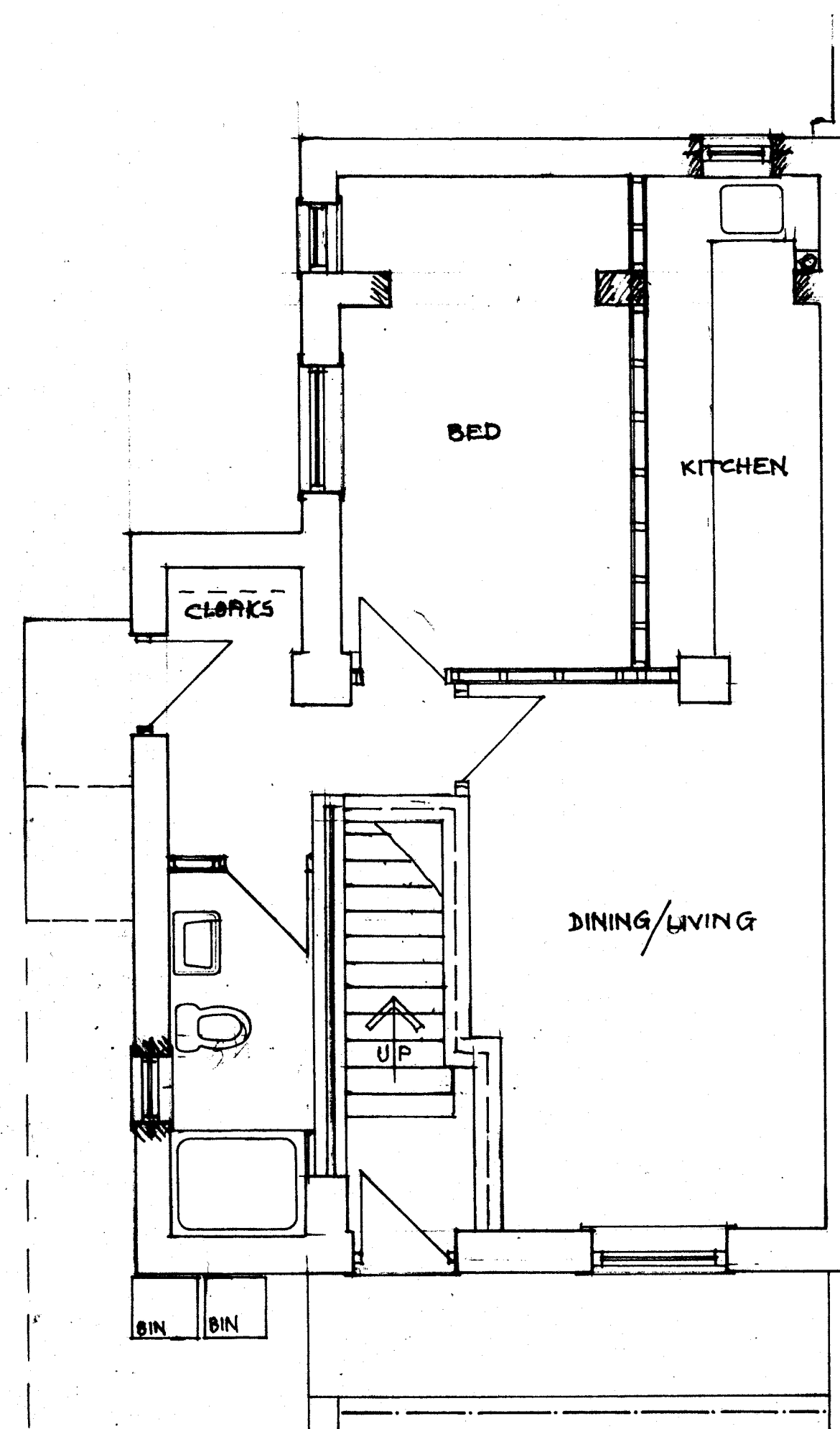




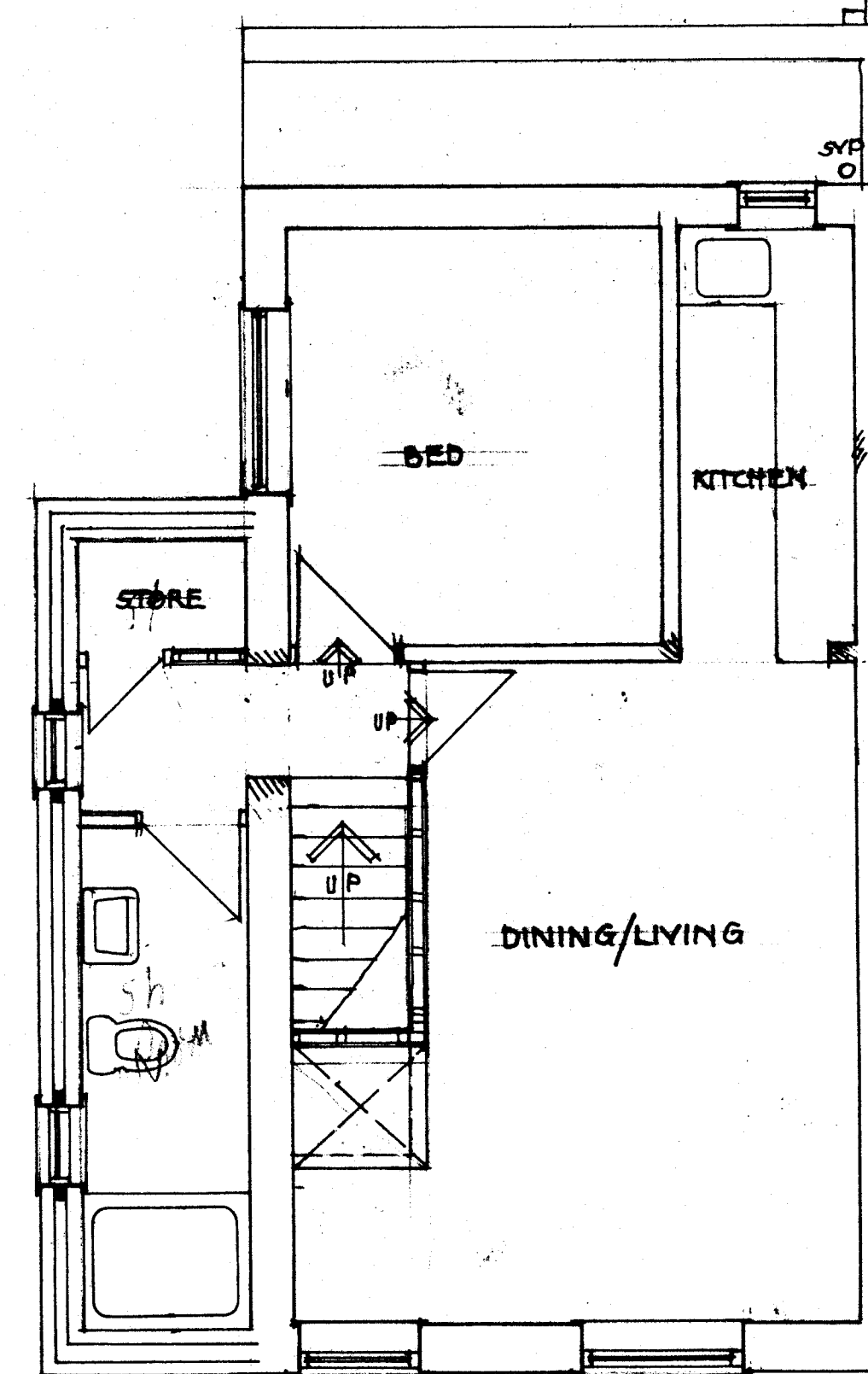
EXISTING GROUND FLOOR



EXISTING FIRST FLOOR



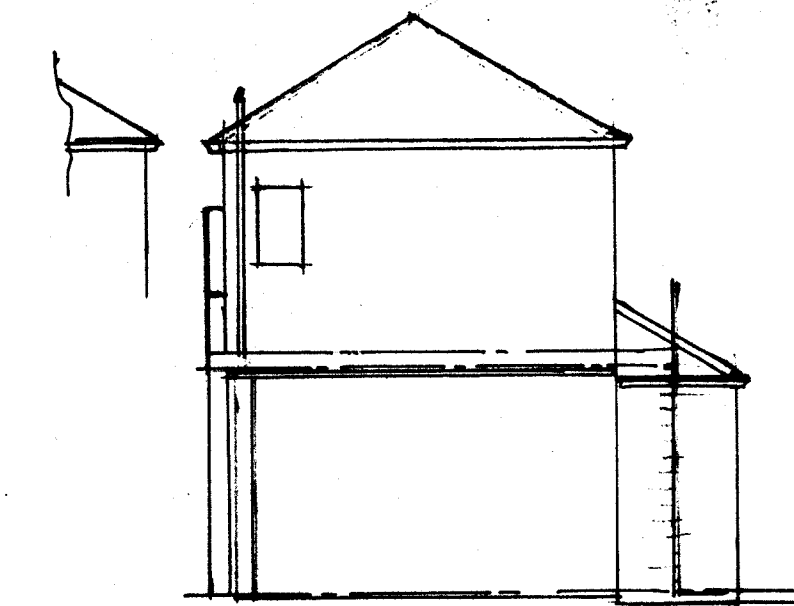
PROPOSED GROUND FLOOR



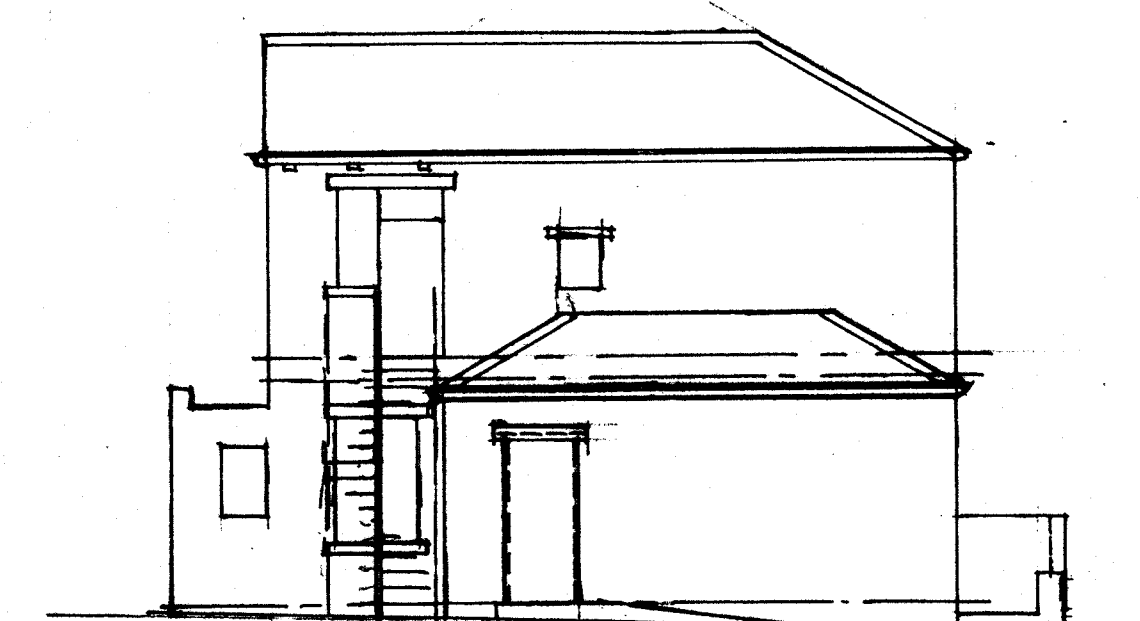

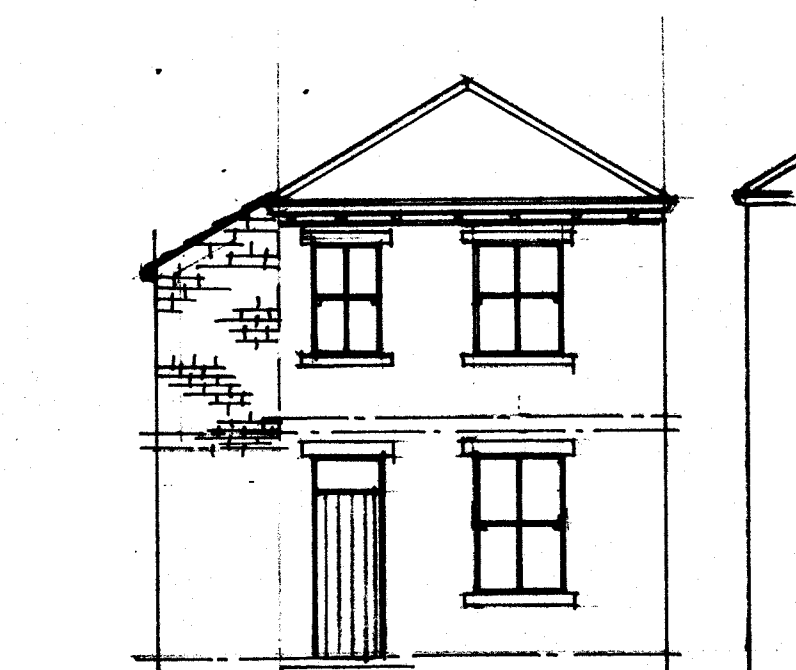

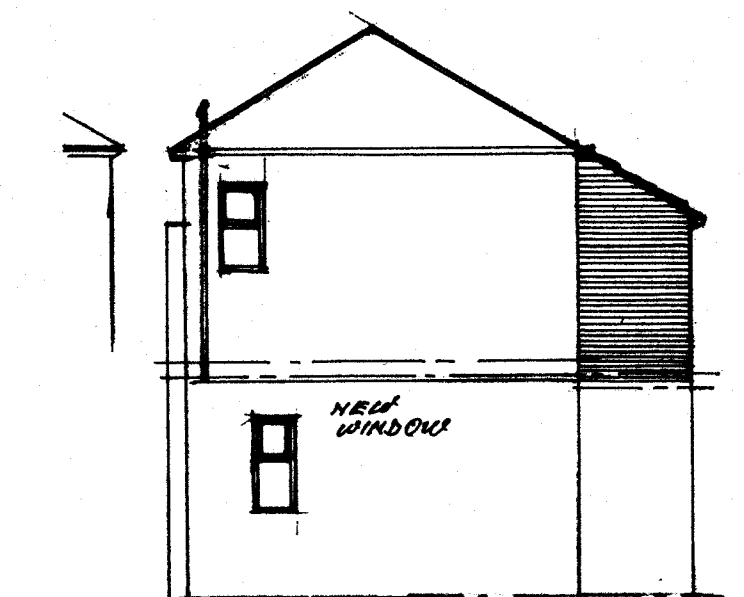

If it does, they must serve the statutory notice on all affected owners. The government has produced an explanatory leaflet which is available from planning services.
