AND 1 NEW KITCHEN VENTILATION EXTRACT

In accordance with the plan(s) and applications submitted to the Council on 16-Jan-2026 subject to the condition(s) specified hereunder:-

1. The development shall be begun not later than the expiration of three years beginning with the date on which consent is granted.

Reason: Pursuant to Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990, as amended by the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and to ensure the satisfactory appearance of the development on completion to retain the significance of the designated heritage asset and to accord with Policies LP2, LP24 & LP35 of the Kirklees Local Plan, as well as policies within Chapter 16 of the National Planning Policy Framework.

3. The kitchen ventilation extract and grill hereby approved shall be of a black or stone colour finish which shall thereafter be retained.

Reason: To ensure the satisfactory appearance of the development on completion to retain the significance of the listed building to accord with policies LP2, LP24 and LP35 of the Kirklees Local Plan, as well as policies within Chapters 12 & 16 of the National Planning Policy Framework.

4. The CCTV cameras hereby approved should be of a black colour finish, with non-ferrous fixings which shall be within mortar joints only.

Reason: To ensure the satisfactory appearance of the development on completion to retain the significance of the listed building to accord with policies LP2, LP24 and LP35 of the Kirklees Local Plan, as well as policies within Chapters 12 & 16 of the National Planning Policy Framework.
