Replacing over 6ft conifers around the boarder of our home for a 5ft wooden fence. We discussed with our adjacent neighbours who all agreed to our development that it would be an improvement to not only our house but to the up keep of our road. The conifers were overgrown and encroaching on the public pathway making it difficult for pedestrians, as the previous home owner didn't maintain them correctly. The fence is a secure barrier, safer for our young children and dogs to be outside next to a busy road, and also extra security as our sons' bedroom is downstairs at the front of the house. The fence also increases our privacy from overlooking neighbours as during summer time the children like to play out on the grassed front lawn. There are other houses in our immediate area with fences above 1 meter around the perimeter of their property, so we were unaware we required planning permission to carry out this work as we were maintaining a consistent streetscape.
