Field Head Lane, Birstall – Drainage Management and Maintenance

I am writing on behalf of Stonewater in respect of the above matter at the development site at Field Head Lane.

I can confirm that as a site wholly owned and to be retained by Stonewater Ltd the ongoing management and maintenance obligations for the site drainage will be undertaken by Stonewater in the long term with the support of external contractors where required. This obligation includes the maintenance of the outfall drain as well as general on site repairs and maintenance to the common areas and landscaping.

All costs associated with the management of the site will be the responsibility of Stonewater Ltd, some costs of which are recoverable from households on the site via the estate service charge. As a provider of affordable homes we are obligated to ensure these costs are kept at an affordable level for our customers. The majority of homes on this development are for affordable rent and therefore Stonewater will retain overall control and responsibility for the management and maintenance of the site.

Our in-house surveyors will be responsible for regular reviews and checks of the site and any works required will be raised directly with our term contractors. All works orders are raised and managed on our in-house software with direct links to our contractors.

For more specialist installations, such as the pumping station, we will enter into a maintenance contract to attend to general servicing and maintenance as well as any emergency call out provisions.

Should the site be adopted by Yorkshire Water in the future, Stonewater will become exempt from any further maintenance and management.
