| <p>I am writing to submit my absolute, uncompromising, and furious objection to planning application 2026/60/90116/E, currently being considered by Kirklees Council.</p> <p>I am disgusted that this proposal has even been allowed onto the agenda. It represents a total failure to protect residents, green spaces, and basic community wellbeing. The destruction of this land is indefensible and reckless. This is not empty land to be exploited — it is a vital part of daily life for local people. Sacrificing it for overdevelopment and profit is shameful.</p> <p>At a time when mental health is at breaking point, it is beyond irresponsible to remove one of the few remaining spaces where residents can find peace, fresh air, and relief from daily pressures. Families, elderly people, and vulnerable residents rely on this area. Ignoring this shows a disturbing lack of empathy and accountability.</p> <p>This development will block my view, reduce daylight, and severely damage my living conditions. My home will become darker, more oppressive, and far less enjoyable. I did not choose to live here only to have my quality of life deliberately destroyed for the benefit of developers.</p> <p>This application places money and private interests above people, community, and long-term sustainability. It reflects planning at its worst — short-sighted, dismissive, and damaging. Residents' concerns are clearly being treated as an inconvenience rather than a priority.</p> <p>Kirklees Council has a duty to serve its residents, not betray them. I expect this harmful and unacceptable proposal to be rejected without hesitation. Anything less would be a serious and lasting failure.</p> |    |
