Three Acer pseudoplatanus (sycamore) were identified as dead or having significant deadwood adjacent to the highway during an inspection on 19/12/25.

52028, 3 on plan, Acer pseudoplatanus (sycamore) 9m, semi mature bifurcated stem at 0.5m one of which is dead. Proposed fell to ground level.

989850, 4 on plan, Acer pseudoplatanus (sycamore) 9m, semi mature bifurcated stem at 0.5m, dead with Kretschmaria deusta identified at base.

Proposed fell to ground level.

989852, 6 on plan, Acer pseudoplatanus (sycamore) 9m, semi mature single stem with dieback from the crown . Reduce leader to live wood and monitor.

7. Identification Of Tree(s) And Description Of Works continued ...

Given the simultaneous deterioration of sycamore and the narrow strip of Kirklees Council owned land at this location (0.5m widening to 1.5m) restricting replanting options and the ongoing deterioration of mature sycamore within 200m on the verge adjoining Almondbury Common it is not proposed to replant and allow any natural regeneration to occur. Extensive planting programmes in more suitable areas as part of efforts to contribute to the White Rose Forest provide immediate compensation for the loss of these trees.
