**KIRKLEES COUNCIL HEREBY REFUSES TO CERTIFY THAT ON 26-JAN-2026 THE OPERATIONS DESCRIBED IN THE FIRST SCHEDULE THERETO IN RESPECT OF THE LAND SPECIFIED IN THE SECOND SCHEDULE HERETO AND EDGED RED ON THE SUBMITTED PLANS WOULD BE LAWFUL WITHIN THE MEANING OF SECTION 192 OF THE TOWN AND COUNTRY PLANNING ACT 1990 (AS AMENDED), FOR THE FOLLOWING REASONS:**

The single storey rear extension does not benefit from a general planning permission under Article 3(1) and Schedule 2, Part 1, Class A of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended) as the development would extend beyond a wall forming the principal and side elevation of the original property and would front a highway contrary to sub-paragraph A.1(e) of Class A. The proposed enlargement would also exceed 4 metres in height and extend beyond a side elevation contrary to sub-paragraph A.1(j) of Class A.
