Lime Tree situated to the rear of 47 Howard way on the school grounds.

The lime tree is well over the property of n47 it is touching the roof of the property and dropping a significant amount of deadwood & snapouts.

The property also has solar panels on the roof and the tree is getting very close to them which is worrying the client understandably.

We would like to request a 4m crown reduction of the tree this is due to the fact that the tree has grown very leggy hence why there are so many snapouts and deadwood.

Normally I would not request such a reduction but the tree has grown too long and thin coupled with the fact that a lime tree is more than able to recover from such a reduction mean I think this would be the correct amount.

Please see pictures of snap outs and dead wood

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
