This would not be pleasing aesthetically so therefore at the footpath boundary, I propose erecting a screening fence or a stone wall with a fence topper to a 2m height to shield wheelie bins and empty beer barrels. Looking at other boundaries on the frontal elevation in the vicinity, the proposal is in keeping with the local area.
