Description of Proposed Works

Please describe the proposed works

The application proposes a single, integrated scheme of domestic alterations and extensions comprising:

- Extension of the habitable space to the lower ground floor into the existing unused void beneath the main ground floor footprint to create improved kitchen and dining accommodation, together with new rear-facing patio doors and fenestration.
- Construction of a first-floor extension above part of the existing flat-roofed structure to provide a master bedroom suite.
- Conversion of the existing attached garage into a bedroom.
- Erection of a new double garage and associated driveway, utilising the existing vehicular access.

Internally, the proposals reorganise the accommodation to address existing shortcomings in room size, layout, and daylight provision, particularly at lower ground floor level. The dwelling will remain a four-bedroom house in principle with one of the bedrooms proposed to function as a sitting room for an elderly parent, the proposal therefore does not increase the number of bedrooms or intensity of occupation.
