In pursuance of its powers under the above-mentioned Act and Order the KIRKLEES COUNCIL (hereinafter called "The Council") as Local Planning Authority hereby refuses consent to:-

ADVERTISEMENT CONSENT FOR INSTALLATION OF 1 BT STREET HUB, INCORPORATING 2 DIGITAL 75INCH LCD ADVERT SCREENS, AND ASSOCIATED BT PHONE KIOSK REMOVAL (WITHIN A CONSERVATION AREA)

At: PAVEMENT O/S, UTILITA, RAMSDEN STREET, HUDDERSFIELD, HD1 2BQ

In accordance with the plan(s) and applications submitted to the Council on 02-Mar-2026. The reasons for the Council's decision to refuse consent for the advertisement(s) to be displayed are:-

1. The proposed digital display screens, owing to their scale, prominent siting, means of illumination and the presence of other similar installations in the immediate vicinity, would be a visually intrusive feature that causes detrimental harm to the visual amenities of the locality and less than substantial harm to the significance of the Huddersfield Town Centre Conservation Area as well as the nearby Grade II listed buildings of 71 New Street, Huddersfield Town Hall, Queensgate Market and 62 New Street and their setting.

Having regard to the cumulative impact of similar installations already in existence, including on Ramsden Street, High Street and New Street, the introduction of a further pair of digital display panels would add further illuminated street clutter which would detract from the character of the wider Town Centre, and would prejudice the aims of the Huddersfield Blueprint, a ten-year regeneration initiative to rejuvenate the town centre and enhance public spaces. Whilst the harm caused to designated heritage assets would be less than substantial, the public benefits associated with the proposed development would not outweigh the harm caused. The proposal is therefore contrary to Policies LP24(a), LP25 and LP35 of the Kirklees Local Plan, Chapters 12 and 16 of the National Planning Policy Framework, advice within the PPG regarding amenity considerations and Sections 66 and 72 of the Planning (Listed Buildings and Conservation Areas) Act 1990.

Clarification Note: Submitted plan (ref 001RevA) includes two site location plans at scale 1:1250 which show different sites. This application is assessed on the basis of the top plan (E414438N416461) as this relates to the site with the same address upon the submitted form.

Pursuant to article 35 (2) of the Town and Country Planning (Development Management Procedure) Order 2015 and guidance in the National Planning Policy Framework, the Local Planning Authority have, where possible, made a pre-application advice service available, complied with the Kirklees Development Management Charter 2015 and otherwise actively engaged with the applicant in dealing with the application.

The case officer did not request amended or additional plans since the planning concerns related to the principle of the development rather than details.

Development within a Coal Mining Area

DEVELOPMENT HIGH RISK AREA - INFORMATIVE NOTE

The proposed development lies within an area that has been defined by the Mining Remediation Authority as containing coal mining features at surface or shallow depth. These features may include: mine entries (shafts and adits); shallow coal workings; geological features (fissures and break lines); mine gas and former surface mining sites. Although such features are seldom readily visible, they can often be present and problems can occur, particularly as a result of new development taking place.

Any form of development over or within the influencing distance of a mine entry can be dangerous and raises significant land stability and public safety risks. As a general precautionary principle, the Mining Remediation Authority considers that the building over or within the influencing distance of a mine entry should be avoided. In exceptional circumstance where this is unavoidable, expert advice must be sought to ensure a suitable engineering design which takes account of all relevant safety and environmental risk factors, including mine gas and mine-water. Any intrusive activities which disturb or enter any coal seams, coal mine workings or coal mine entries (shafts and adits) requires a Mining Remediation Authority Permit. Such activities could include site investigation boreholes, excavations for foundations, piling activities, other ground works and any subsequent treatment of coal mine workings and coal mine entries for ground stability purposes. In areas where shallow coal seams are present caution should be taken when carrying out any on site burning or heat focused activities.

If any future development has the potential to encounter coal seams which require excavating, for example excavation of building foundations, service trenches, development platforms, earthworks, non-coal mineral operations, an Incidental Coal Agreement will be required. Appeals to the Secretary of State

If you are aggrieved by the decision of your Local Planning Authority to refuse this application, then you can appeal to the Secretary of State under section 78 of the Town and Country Planning Act 1990.

All advertisement appeals have to be submitted to the Secretary of State within 8 weeks of the date of issue of the Local Planning Authority's decision against which you are appealing.

Appeals must be made using a form which you can get from the Secretary of State at Temple Quay House, 2 The Square, Temple Quay, Bristol BS1 6PN (Tel: 0303 444 5000) or online at <https://www.gov.uk/appeal-planning-decision>. The Secretary of State need not consider an appeal if it seems to the Secretary of State that the local planning authority could not have granted advertisement consent or could not have granted it without the conditions they imposed, having regard to the statutory requirements, to the provisions of any development order and to any directions given under a development order.
