Horse Chestnut tree with a TPO on it. This is a very large tall tree, originally there were four trees, one each in the four townhouses. Number 2 Springfield Lane have had their tree removed due to disease. Number 4 Springfield Lane, their tree fell down due to bad weather many years ago onto the highway and pavement and Kirklees Council came and removed this. Number 6 and number 8 Springfield Lane both have their horse chestnut trees in their gardens. No 6 Springfield Lane is on the market and vacant.

## 7. Identification Of Tree(s) And Description Of Works continued ...

We live at number 8 Springfield Lane and our elderly neighbours are constantly asking us to trim the tree back as it is touching her property over her roof, causing problems with moss and roof tiles and light issues. Also her house is through by light so when tree is in full bloom it blocks out all light to her house her kitchen especially.

The tree overhangs the pavement on the road side of North Road causing problems with slippery leaves and all the other debris from a horse chestnut, buds, flowers and conkers. We have a dog who spends lots of time in the garden as does our family with small children and constantly we get heavy large conkers falling into the garden which hurts us and the dogs when falling from a great heights.

Recently a very long large branch has fallen off the tree into our garden (see photo). I am very concerned when my grandchildren play in the garden of the falling debris from this tree.

I have today had a visit and verbal advice from a Kirklees approved Tree Surgeon (Benjamin Edwards of B Edwards Tree Services Tel 07881 370562.

Due to the problems we have with the neighbours roof and our light and safety issues, they have advised to have a 3 metre reduction of the crown and to remove epicormic growth and are willing to carry out the work once approved by Kirklees please.

We are also in a conservation area. I attach several photos of the tree, also a tree in the neighbours garden is on them, and the same work has been advised for 6 Springfield Lane, and I have passed this to the owner of this property as a separate issue.
