Identification of Tree(s) and Description of Works

G001 is a group containing approx. 25 self-seeded young and semi-mature trees (common ash, sycamore, holly, and hawthorn). Many these trees are growing out of river bank retaining wall and/or from bases of adjacent commercial units. Street lighting power cables also pass through group, and with trees growing directly beneath, there are branches which are entangled in the wires.

The applicant wishes to remove the trees to mitigate future damage to the commercial units and to the river bank retaining wall. Removing the trees will also allow the applicant to remove fly-tipped waste from the land and repair/reinstate the fence (which is currently in a state of disrepair).

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
