In pursuance of its powers under the above-mentioned Act and Order the KIRKLEES COUNCIL (hereinafter called "The Council") as Local Planning Authority hereby permits:-

CHANGE OF USE FROM DWELLINGHOUSE (USE CLASS C3) TO MEDICAL / HEALTH CLINIC (USE CLASS E(E)) INCLUDING HAIR LOSS CONSULTATIONS, NON-SURGICAL TREATMENTS, AESTHETIC PROCEDURES AND LIMITED HAIR TRANSPLANT PROCEDURES (MAXIMUM TWO DAYS PER CALENDAR MONTH), WITH ASSOCIATED INTERNAL ALTERATIONS.

At: 1267, LEEDS ROAD, BRADLEY, HUDDERSFIELD, HD5 0RJ

In accordance with the plan(s) and applications submitted to the Council on 16-Mar-2026, subject to the condition(s) specified hereunder:-

1. The development hereby permitted shall be begun within three years of the date of this permission.

Reason: Pursuant to the requirements of Section 51 of the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice, except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and so as to ensure the satisfactory appearance of the development on completion, and to accord with Policies LP1, LP2, LP13 LP21, LP22, LP24, LP28 and LP51 of the Kirklees Local Plan, Chapters 2, 6, 7, 9, 12 and 15 of the National Planning Policy Framework.

3. The principle use of the building shall be restricted to medical / health clinic (Use Class E(e)) including hair loss consultations, non-surgical treatments, aesthetic procedures and limited hair transplant procedures and shall not be used for any other purpose falling within Use Class E other than those uses considered ancillary to the use as a medical/health clinic.

Reason: In the interests of highway safety and to ensure that use of the building would not generate high numbers of vehicles at any one time that would result in an oversubscription of on-street parking in accordance with Policies LP21 and LP22 of the Kirklees Local Plan and advice within the National Planning Policy Framework.

4. Unless otherwise agreed in writing by the Local Planning Authority there shall be no activities carried out at the premises including dispatches to and or dispatches from the premises, outside the hours of 0930 and 2000 Monday to Friday and 0930 to 1600 Saturdays. No activities shall take place on Sundays or Bank Holidays.

Reason: In the interests of residential amenity and to accord with LP24 of the Kirklees Local Plan and advice within the National Planning Policy Framework.

NOTE: Kirklees Council has powers under Section 60 of the Control of Pollution Act 1974 to control noise from construction sites and may serve a notice imposing requirements on the way in which construction works are to be carried out. It has additional powers under Sections 80 of the Environmental Protection Act 1990 to prevent statutory nuisance including noise, dust, smoke and artificial light and must serve an abatement notice when it is satisfied that a statutory nuisance exists, or is likely to occur or recur. Failure to comply with a notice served using the above-mentioned legislation would be an offence for which the maximum fine on summary conviction is unlimited.

- You should note the triggers for compliance with the conditions of this planning permission. This Authority is committed to processing applications to discharge conditions in a timely manner. It is important to ensure that submissions are made as far in advance of the trigger to allow time for adequate consultation, discussion and in some circumstances publicity.

Appeals to the Secretary of State

- If you are aggrieved by the decision of your Local Planning Authority to grant it subject to conditions, then you can appeal to the Secretary of State under section 78 of the Town and Country Planning Act 1990.
- If an enforcement notice is served relating to the same or substantially the same land and development as in your application and if you want to appeal against your Local Planning Authority's decision on your application, then you must do so within:
 - i) 28 days of the date of service of the enforcement notice, or
 - ii) within the specified period, starting on the date of this notice,whichever period expires earlier.
- If you want to appeal against your Local Planning Authority's decision then you must do so within the specified period, starting on the date of this notice.
- The "specified period" is 12 weeks where the development relates to a "minor commercial application" as defined within the Town and Country Planning (Development Management Procedure) Order 2010 (as amended), or 6 months in any other case.
- Appeals must be made using a form which you can get from the Secretary of State at Temple Quay House, 2 The Square, Temple Quay, Bristol BS1 6PN

- You must use the correct Planning Appeal Form when making your appeal. If requesting forms from the Planning Inspectorate, please state the type of application that the appeal relates to so they can send you the appeal form you require.
- The Secretary of State can allow a longer period for giving notice of an appeal, but he will not normally be prepared to use this power unless there are special circumstances which excuse the delay in giving notice of appeal.
- The Secretary of State need not consider an appeal if it seems to him that the Local Planning Authority could not have granted planning permission for the proposed development or could not have granted it without the conditions they imposed, having regard to the statutory requirements, to the provisions of any development order and to any directions given under a development order.
- In practice, the Secretary of State does not refuse to consider appeals solely because the Local Planning Authority based their decision on a direction given by him.

Please note, only the applicant possesses the right of appeal.

Purchase Notices

- If either the Local Planning Authority or the Secretary of State refuses permission to develop land or grants it subject to conditions, the owner may claim that he can neither put the land to a reasonably beneficial use in its existing state nor render the land capable of a reasonably beneficial use by the carrying out of any development which has been or would be permitted.

In these circumstances, the owner may serve a purchase notice on the Council. This notice will require the Council to purchase his interest in the land in accordance with the provisions of Part VI of the Town and Country Planning Act 1990.
