The large span entrance on the front elevation has proven costly and complex, therefore we are seeking to amend this. Also, we are taking the opportunity to introduce a new recessed porch element on the east elevation, and address condition number four on the approval notice regarding the east and west first floor windows. A full statement is included in the application.

1. Reduce width of front porch and bring more of the ground floor walling in line with the rest of the front elevation.
2. Removal of timber cladding on all elevations and replace with the same white render as the rest of the facade.
3. Addition of a recessed porch area to the side entrance on the east elevation.
4. Adjustment of the first floor windows on the east and west elevations to allow them to be openable and not kept fixed.
