Details of the pre-application advice received

The council's pre-application advice states that the proposed front, side, and rear extensions are too large and cumulatively disproportionate compared with the original house. Because the property is in the Green Belt, extensions must remain subordinate to the original building and preserve openness, but the scale and massing of the proposal would overwhelm the dwelling and harm the character of the area. The scheme may also negatively affect the neighbour at 319a Halifax Road by creating an overbearing impact and loss of outlook, and parking provision would need to show three spaces for a property of the proposed size. Overall, the council indicates the proposal is unlikely to be supported in its current form, though a smaller, more sensitive extension would be acceptable.

The revised scheme has been significantly amended in response to the pre-application advice, with the scale and extent of extensions reduced to create a more proportionate addition to the existing dwelling. The proposal has been simplified to focus development primarily to the rear and side of the property, with the original front elevation and form of the house remaining the dominant element within the street scene. This approach reduces the cumulative massing previously identified as a concern and ensures the extensions read as subordinate to the host building.

The revised layout and elevations demonstrate a more compact and balanced design, with a reduced footprint and clearer relationship to the existing dwelling. By limiting the extent of development and rationalising the built form, the proposal better preserves the openness of the Green Belt and avoids the visually dominant form previously highlighted by officers. The amendments also maintain appropriate separation from neighbouring properties, helping to address earlier concerns relating to residential amenity.
