Subject: Notification of Proposed Removal of Sycamore Tree in Conservation Area

I am submitting this notice to request permission to remove a mature sycamore tree located on my property, which lies within a designated conservation area.

The removal is necessary due to several significant safety concerns:

Risk to electricity supply:

The tree is currently resting on the main electricity supply cable to the property. This poses a risk of damage to the supply infrastructure and potential electrical hazards.

Damage to pathway and surrounding structures:

The tree's root system has lifted and displaced the pathway, creating a trip hazard and causing structural damage that continues to worsen.

Structural instability of the tree:

The tree has a pronounced fork that shows signs of potential failure. If the fork were to split, there is a real risk that part of the tree could fall onto the adjacent main road, endangering road users and pedestrians.

Falling branch hazard, particularly to children:

The tree has shed branches previously, and there is an ongoing risk of further branch drop. This is of particular concern as we have children in our household, increasing the potential for injury.

Given these combined risks, I believe removal is the most appropriate and responsible course of action. I have provided photographs with this application.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) – Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
