TREE (T1 ON SKETCH PLAN) - SPECIES UNKNOWN (MATURE TREE) LOCATED WITHIN A CONSERVATIONS AREA.

THE TREE IS CURRENTLY HEAVILY COVERED IN IVY, WHICH OBSCURES VISIBILITY OF THE CANOPY AND STRUCTURE. THE CROWN CONTAINS A SIGNIFICANT AMOUNT OF DEADWOOD, WITH MULTIPLE DRY AND BRITTLE BRANCHES EVIDENT. SECTIONS OF DEADWOOD HAVE ALREADY FALLEN AND ARE IMPACTING THE GARDEN AREA AND PROPERTY, PRESENTING AN ONGOING RISK OF DAMAGE AND POTENTIAL INJURY.

PROPOSED WORKS - CROWN REDUCTION TO A MAXIMUM HEIGHT OF ADJACENT TREE (T2 ON SKETCH PLAN); REMOVAL OF DEADWOOD THROUGHOUT THE CROWN; REMOVAL OF MAJOR IVY GROWTH TO ALLOW FULL INSPECTION AND IMPROVE TREE HEALTH; REMOVAL OF ANY UNSAFE, DAMAGED OR HANGING BRANCHES.

REASON FOR WORKS - THE WORKS ARE REQUIRED ON SAFETY GROUNDS DUE TO FALLING BRANCHES AND THE RISK POSED TO PEOPLE AND PROPERTY. THE PRESENCE OF EXTENSIVE DEADWOOD AND IVY GROWTH IS CONTRIBUTING TO STRUCTURAL DECLINE AND INCREASING THE LIKELIHOOD OF FURTHER BRANCH FAILURE. CROWN REDUCTION HAS BEEN PROPOSED INSTEAD OF FELLING AS WE UNDERSTAND THE IMPORTANCE OF THE CONSERVATION AREA AND WANT TO ENSURE MINIMAL IMPACT.

WORKS ARE PROPOSED FOR SEPTEMBER TO AVOID THE BIRD NESTING SEASON. HOWEVER, SHOULD URGENT SAFETY WORKS BE REQUIRED PRIOR TO THIS, ALL REASONABLE CARE WILL BE TAKEN, INCLUDING INSPECTION FOR ACTIVE NESTS AND WORKS WILL BE CARRIED OUT IN ACCORDANCE WITH WILDLIFE LEGISLATION.

ACCESS TO UNDERTAKE THE WORKS WILL BE REQUIRED VIA ADJACENT CHURCH LAND. PERMISSION WILL BE SOUGHT FROM THE LANDOWNER PRIOR TO COMMENCEMENT.

THE TREE IS NOT SUBJECT TO A TREE PRESERVATION ORDER (TPO) BUT IS LOCATED WITHIN A CONSERVATION AREA.
