2. Yew (adjacent to T18 on original plan)
3. Beech (labelled as beech sapling adjacent to T17 on original plan)
4. Silver Birch (labelled T1. T1 was an Ash damaged in a storm and replaced with a Silver Birch)

7. Identification Of Tree(s) And Description Of Works continued ...

The following proposed works have been advised by our tree surgeon-Able Tree Services and are as follows;

1. The lime is close to the house and needs the epiphytic growth removing to a height of approx 5m to allow light below.
2. The Yew overhangs a neighbouring property and the owner has asked if some of the overhanging branches can be removed/shortened as these significantly affect the light in their garden. The tree specialist said this could be done whilst keeping the shape of the tree overall.
3. The Beech was a small sapling when we first moved in in 1989. It is now large and overhangs the access road significantly. there are several low overhanging branches which are a risk to passing vehicles. The tree specialist suggested a crown lift to 4metres height.
4. The Silver Birch is a replacement tree. It replaced a storm damaged Ash which had to be removed many years ago. The Ash was a landmark tree on the main road. The Birch has grown into a fine tree and is a landmark tree in its own right. However, the lower branches are interfering with a nearby telegraph pole with attachments for fibreoptic cabling and there is a risk of damage to this in windy conditions. The tree specialist suggested removing the lower branches, keeping the overall shape intact.

I have sent a plan and photos of the trees in question to help illustrate the issues.
