## Identification of Tree(s) and Description of Works

T1 Oak, T2 Ash and T3 Sycamore of MWA Root Barrier Proposal  
Root Barrier is proposed to the left side of 51 Penistone Road, HD8 0AW to mitigate the influence of vegetation to the NW of the property that has been implicated in subsidence damage.  
There will be root severance of T1 Oak, T2 Ash and T3 Sycamore which are subject to a Tree Preservation Order.  
It is proposed that there will be a 15 metre barrier to the left/north westerly elevation of the property as per MWA Root Barrier proposal.  
We are seeking consent to the installation of the barrier.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
