The installation will be performed by Motability's chosen installer. In order to minimise the visual impact we requested the installer do the following:

1. Run the mains feed to the charger externally alongside the existing mains supply cabling and using visually similar materials. Cabling on the exterior of the property would be Black 6mm 3 core SWA cabling approximately 14-16mm outside diameter, where possible clipped alongside the existing electricity mains supply cables and the clips fastened into mortar where possible.
2. Install a small charger unit (Ohme ePod) in a dark material, with one Type 2 charging port suitable for an untethered cable.
3. Install the charger at a low height and near the neighbouring existing fence.
4. Fittings to be attached into mortar where possible
