Tree in question is a sycamore 04/90/t1

Requesting Crown lifting and crown reduction 3m x 3m of tree in question due to the sheer size that is out of control for a built up area which is overhanging across boundaries, growing through phone lines, blocking access for emergency vehicles such as fire service and growing in to boundary fences, excessive fall of branches causing permanent damage to vehicles. crown to be lifted to appropriate height to allow for emergency service access.

multiple serious floods occurred on our property from nov 25-dec 25. causing excessive damage to our house with 5ft of water accumulating inside. upon inspection of the culvert running under our property large tree roots were found within and around the collapsed culvert. this is a serious risk to our property and our lives due to the sheer amount of water that engulfed our House in such a short space of time and also putting a risk to our pets lives who reside in the property when we are out. there is evidence noted of this as Kirklees council attended our property regarding this.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
