Tree in question is a beech 18/10/t1

Requesting Crown lifting and crown reduction 3m x 1.5m either side of tree in question due to the sheer size that is out of control for a built up area which is overhanging across boundaries, growing through phone lines, blocking access for emergency vehicles such as fire service and growing in to boundary fences, excessive fall of branches causing permanent damage to vehicles. crown to be lifted to appropriate height to allow for emergency service access and preserve our boundary fence.

Neighbours have had to cut their hedges lower in areas due to the branches hanging low. It is growing further towards our house. We are requesting to cut it to a more manageable size where our property and surrounding properties aren't being affected.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
