The application seeks planning permission for the change of use of a former caretaker's house (Use Class C3) to education use (Use Class F1) to provide an Additional Resourced Provision (ARP) associated with New Mill Infant School. The ARP will support a small number of pupils requiring specialist provision, enabling them to access targeted support alongside integration with mainstream teaching and learning within the school. The proposal involves internal alterations to adapt the existing layout to meet the needs of the provision. No extensions or additional built accommodation are proposed. Minor external alterations may be undertaken to facilitate access and safe operation of the use. The building will continue to operate as part of the wider school site and will utilise the existing shared access from Kirkroyds Lane.

The site comprises a former caretaker's house located within the curtilage of New Mill Junior School. The property previously functioned as ancillary residential accommodation associated with the school, with the last caretaker vacating the property in 2022. Since that time, the building has remained vacant and is no longer used for residential purposes. It sits within the operational school site and shares access with the school from Kirkroyds Lane. The property does not operate as a separate planning unit and remains functionally and physically linked to the wider school site.
