Replace the existing open wire conductors in favour a Aerial Bunched Conductor

In order to improve the security of electricity supplies and also resolve any safety issues Northern Powergrid propose to erect Aerial Bunched Conductor (see attached photos) along the route of the existing overhead electric line. Aerial Bunched Conductor is deemed as the design successor of the existing open wire conductor
