Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

On advice from Stephensons Tree Surgeons, I propose the following works:

1. The hawthorn at the west end of our property adjacent to trust lands - to cut to approx half height, for general health of the tree, and to reduce shade and dankness overlooking the neighbours.
2. Cut back the alders/willows overlooking our parking - again, to reduce to half height (approximately), to remove overhanging above the maple, to reduce risk of branches falling on the shed, and reduce general weight/height as the trees are on a narrow bank above the goit and we want to reduce the risk of subsidy into the water.
3. Possible third job - the alder at the end of the garden with a heavy low horizontal branch virtually at water level, I'm worried it could start to crack, but I don't think there's any real safety or environmental issue, it's more for the health of the tree.

We do not believe that any of these trees are subject to a Tree Preservation Order.
Tree locations are marked with matching numbers on the attached sketch.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
