Tree Application 1 - Site of the Beech Tree

Photograph - Tree 1 - This shows the condition of our roof this week, we have tried to clean and remove as much of the blossom as possible, but this is an ongoing issue as leaves fall later in the year, it also means that we have a lot of Moss growing on that side of our roof which is a concern as Moss can track under the tiles and cause damp issues.

Photograph - Tree 2 - This is taken from inside our Sun Lounge and shows how the trees branches are growing over our property and reducing the light available.

Photograph - Beech Tree - This was taken earlier this year to show the spread of the trees branches.

Our Neighbour has a Beech Tree that predominantly grows over our Garden and specifically over our Sun Lounge.

It causes a nuisance as it drops blossom, leaf sepals and leaves into our gutters which then block the gutters and the down pipes to the drains.

We would like to cut this tree back so that it gives us clearance to prevent such a nuisance.

You granted us permission to cut the tree back to give 2 Meters of clearance, our Tree Surgeon has visited site and stated that we would be wasting our money as the problem would soon return, and that we need to cut back further than the standard 2 Meters you advise.

Our Neighbour is happy for us to proceed with the work and asks that the tree is reduced over his driveway to keep it in proportion.

We want to cut the tree back far enough to reduce the issues it causes us, to that end we would really like the Tree Department to visit us to discuss this and to agree a plan going forward.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
