The development will consist of multiple rows of solar panels mounted on a low-profile frame, together with associated inverter and electrical equipment, cabling, and ancillary infrastructure. The array will be located adjacent to existing farm buildings and designed to minimise visual impact. The primary use of the land will remain agricultural, with no significant change of use proposed.

The proposed development comprises a small-scale ground-mounted solar photovoltaic array within an area of existing grassland. The site is of low ecological value and does not contain any priority habitats or significant vegetation. The development will have a limited footprint and will not result in the loss of important ecological features. Grassland beneath and around the array will be retained and can continue to be managed in a way that supports biodiversity. There is potential for biodiversity enhancement through low-intensity management, such as allowing natural grass growth and maintaining habitat continuity. Given the small scale and nature of the proposal, the development is not expected to result in any significant adverse impacts on biodiversity, and opportunities exist to maintain and potentially enhance biodiversity on site.
