Details of the pre-application advice received

Officer accepted that weight loadings prevented raising of parapets by use of stone. The use of decorative historic or mural patterns to the perforated screen were considered, but discounted on her advice as they would detract from the architectural interest and appearance of the listed bridge. A more simple, utilitarian approach was preferred.
