The Application drawings, as originally submitted, included a pitched roof at a low pitch to accommodate the existing first floor window cill heights. A natural stone slate could not be included as the minimum recommended roof pitch for stone slates can not be attained.

The proposal is to remove the pitched roof and include instead a flat roof with a single-ply membrane covering. This will be behind a low height parapet wall to the perimeter of the roof. Approval of this is sought via variation of the conditions imposed on the Planning Consent 2026/62/90330.
