Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Group of conifers (G1) to be removed as they have been planted in a very unsuitable place and have been subdued by surrounding trees/hedges that have a higher amenity value such as hawthorn etc. the conifers are preventing access to the rear of the garden and their removal will benefit adjacent trees/shrubs.

T1 is a small multi stemmed willow which the applicant would like removing to ground level or near ground level as it has started to shade the garden and due to larger adjacent trees is growing at a disruptive angle. The applicant would like to allow it to regenerate and keep it maintained at a suitable height.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
