The majority of the village is on the opposite side of the A road so that children attending the first school would have to cross it. Many vehicles using the road pay little heed to the speed limits and the level of traffic in the area is already of great concern to residents of all the surrounding villages, more residents will only add to the problem.</p> <p>This type of development will do little to relieve the pressure on the need for low cost housing as people on a very limited income can not afford to live so far away from work and amenities.
