It is noted within the submitted plans (drawing 02) there would be creation of new fencing along the boundary. It is recommended that any boundary treatment above 1m in height be designed as a low level wall with pillars and railing or fencing infill.

Overall, in summary, it is considered that the two storey side extension would integrate with the existing dwelling and would respect its character and would be in keeping with the character of the area"
