Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

One oak tree (10a/03) to the rear of the property.

Following consultation with an arboriculturist (details below), it was deduced that this tree is in very poor health and showing signs of significant decline. Visible leaking of sap is present to the trunk areas of the tree and heavy vertical cracking / breaking of the bark to the base and throughout the trunk, indicating possible structural issues. Areas of bark are also missing to the trunk section and upon touching some areas, the bark comes away from the tree completely and with ease. Rotting is visible to one of the largest branches coming over the property garden area and this is likely dead or heavily diseased given the level of damage visible. There are also some signs of wilting leaves and poor production / spread throughout the tree. The tree is displaying small branch dieback which is continuous throughout the year and this is visible within the gardens around it.

The tree poses a risk to not only the property in which it stands, but also to neighbouring houses due to the close proximity. There are health safety concerns should this tree remain in place due to the above mentioned condition. At present, there is a large percentage of the crown overhanging adjacent property boundaries and could cause harm should they fall.

It has been recommended, given the poor condition of the tree, that this application considers the felling completely, as to only thin or reduce the crown would not address the long term concerns of this tree and the potential issues it could cause should it fall.

Photographs have been provided in the application to demonstrate the above detailed damage/disease to the tree, along with the location and boundaries / neighbouring properties.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
