Why do you consider that a Lawful Development Certificate should be granted for this proposal?

The proposed structure is a twin-unit caravan designed and constructed in accordance with the dimensional requirements of the Caravan Sites Act 1968 (as amended) and falls within the statutory definition of a caravan. The caravan/mobile home will be sited within the residential curtilage of the existing lawful dwellinghouse and will be used solely for purposes incidental and ancillary to the enjoyment of that dwellinghouse.

The caravan/mobile home will not constitute a separate planning unit, will not be separately occupied, sold, leased or rented, and will remain functionally linked to the principal dwellinghouse at all times. The proposed development will not result in the creation of an independent dwelling and will continue to operate as accommodation ancillary to the main residence.

The structure will remain capable of being transported in accordance with the provisions of the Caravan Sites Act and will be installed using a reversible foundation system, ensuring that it retains its status as a caravan rather than a building.
