The requirement to clad the dormer in Roman concrete tiles is not considered appropriate in this instance due to both practical and design considerations. Roman concrete tiles are designed primarily for pitched roof applications and their use as vertical cladding on a dormer can result in a bulky, visually heavy appearance that is out of proportion with the scale of the dormer. The detailing required to install roof tiles vertically can also create maintenance and weatherproofing challenges, increasing complexity without delivering any significant visual benefit.

If you wish the existing condition to be changed, please state how you wish the condition to be varied

A variation is sought to replace the approved Roman concrete tile hanging with anthracite aluminium cladding, as it provides a lighter, less bulky and more practical finish for the dormer, resulting in improved detailing and appearance. In addition, only one side of the dormer will be visible from the main carriageway, meaning the proposed material change will have a limited impact on the street scene while maintaining the overall character of the property.
