Change of use of a former caretaker's bungalow from residential accommodation (Use Class C3) to ancillary educational accommodation associated with St Patrick's Catholic Primary Academy (Use Class F1).

The building will be incorporated into the operational school site and used as additional classroom space to support teaching and learning activities. Internal alterations are proposed to facilitate the change of use, including the installation of fire doors and associated fire safety improvements, improvements to the existing kitchen facilities, and the reconfiguration of internal spaces to create suitable teaching and learning areas.

No significant external alterations are proposed as part of this application, and the building will remain within the existing school grounds.

The site comprises a former caretaker's bungalow located within the grounds of St Patrick's Catholic Primary Academy. The building was historically used as residential accommodation for the school caretaker and forms part of the wider school site.

The bungalow is no longer occupied as caretaker accommodation and is currently underutilised. The surrounding site continues to operate as a primary school, including associated buildings, playgrounds and playing fields.
