Advised Works;

In relation to your guidance document, we are asking for two items to be carried out as follows;

- Crown Thinning, After consulting with an authorised arborist as stated above, they advised that it requires considerable thinning to allow for air flow to reduce tree sway and flexing, allowing air flow to move more freely reducing these effects.
- Crown Reduction, the same consultant advised that it is too close to the building (within 1 meter above ground level starting at below first floor window level) its within reach and could do with 10 – 20 ft in reduction around the tree in order to keep it balanced. Thus providing good building clearance.

Reasoning;

Please see photographic evidence along with plan.

The first photograph looking down Dunbottle Lane, it shows its furthest extent (0.69 m using digital measurement) from the house. The second photograph from the rear elevation shows the closest branch being below the first floor window.

Over the years trees with TPOs have fallen, luckily with no reported injuries, this doesn't mean that it will not fall towards the house (Quite possible as the tree is on a bank towards the house) and where I sleep, quite easily taking a third of the house with it due to its height. This causes undue anxiety and stress when going to sleep, especially in high winds as you would probably agree.

Due to the location of the tree and its large reach in to number fours property (photograph three) extends a great deal in to their property line, it could also cause damage or danger to life there also.

As well as possible danger and damage, it is causing reduction of light at both ground and first floor level. Without serious intervention there is risk to personal physical danger and in turn a reduction of valuation to both properties and sale in the future. In addition, there has been a remarkably large increase in bird excrement to the extent that clothes cannot be dried in both properties back gardens. It effects both dwellings in spring and summer to the extent we receive complaints about it from number four. The amount of excrement around the back garden causes a great deal of cleaning and management every year, eventually causing damage to the work that has been done to improve the garden. As you can imagine this can be a very unpleasant job on a continual basis and a health hazard in doing so.

I would appreciate your consideration and the serious concerns and circumstances I have to manage yearly and for future generations to preserve the longevity of the tree and properties surrounding it.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
