Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Four trees which are all protected by TPOs to be pruned back (T1, T3, T4 and T5) maintaining the tree health and avoiding risks of potential damage to adjacent property roofs.

T1 - Beech - located in adjacent garden - crown lift removing small diameter branches to give 3-4 metres ground clearance and remove lowest limbs over the roof of Parish Rooms. Cleanout crown removing dead and dying wood, weak, crossing/rubbing branches and stubs. Reduce back from the property, reducing branches back to a suitable side branch to give 2-3m clearance. If required, crown thin removing 20% of the crown mass, thinning the canopy evenly, i.e. thinning branches in the outer portion of the canopy to prevent "lion tailing".

T3 - Sycamore - crown lift removing small limbs closest to property gable end and lowest secondary branch drooping over lawned area and adjacent. Cleanout crown removing dead and dying wood, weak, crossing/rubbing branches and stubs. Reduce back from the property, reducing branches back to a suitable side branch to give 2-3m clearance. If required, crown thin removing 20% of the crown mass, thinning the canopy evenly, i.e. thinning branches in the outer portion of the canopy to prevent "lion tailing".

T4 - Sycamore - crown lift removing lowest secondary branches drooping over lawned area and adjacent property. Cleanout crown removing dead and dying wood, weak, crossing/rubbing branches and stubs. Reduce back branches and if required, crown thin removing 20% of the crown mass, thinning the canopy evenly, i.e. thinning branches in the outer portion of the canopy to prevent "lion tailing".

T5 - Beech - crown lift removing lowest secondary branches, reducing back branches and cleanout removing dead and dying wood, crossing/rubbing branches and stubs. Crown thinning removing 20% of the crown mass, thinning the canopy evenly, i.e. thinning branches in the outer portion to prevent "lion tailing".

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) – Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
