Existing materials and finishes:

All external materials relating to the external installation of the proposed equipment are new to the building. This includes the outdoor unit, pipework and insulation

Proposed materials and finishes:

The main external unit (Heat Pump) will sit at the front left of the house in view of the closest main highway but faced away from the road. The primary pipe route (hot and cold feed) from the heat pump will enter into the porch via 2x 70mm holes, approximately 1 meter above the height of the HP (same level as the top of porch window). This is to allow the pipes to run at high level once they enter the property and to the internal component location. The physical diameter of the pipework is approximately 66mm. Due to this, the holes are drilled slightly bigger.

Existing materials and finishes:

The new proposal will utilise the current existing skeleton pipe system contained within the property for hot/cold pipes to feed all radiators.

Proposed materials and finishes:

The primary pipe route from the heat pump will enter into the porch and will run at high level in the kitchen. At the right end corner of the property, the pipes will lead towards the landing floor and then into bedroom 3. At this point, they will then be brought down into kitchen to connect with indoor unit. The main internal unit will be located inside the kitchen (100 litre unit will go where the current gas boiler is)
