Hawthorn (T1) - the height of this tree is blocking light into the neighbouring property (71 Brougham Road). The owners of 1 Wellington Terrace (Robert and Julie Lee) have agreed with us to have the tree pruned to the level of the neighbouring Hawthorn tree (T2), the Buddleia (B1) and the Viburnum Tinus (B2). I have also attached a PDF of the sketch plan, as I could not paste it into this document.

The attached photographs have been annotated to show how much of the tree we wish to prune. We have discussed this with a tree surgeon, who has quoted for the work and informed us that we must submit this application.
