The application site has an area of approximately 34 square metres, as defined by the red-line boundary, and is therefore below 0.2 hectares. The Priority Habitat Inventory mapping has been reviewed. While priority habitat is identified within the wider area and therefore within 500 metres of the site, the proposed development will not result in the loss or degradation of any priority habitat. The proposal comprises the formation of a vehicular crossing from Jilley Royd Lane connecting to the existing gated woodland maintenance access, together with the relocation of the existing timber gates approximately 5 metres back from the rear edge of the public footway. The gate relocation is within the existing access area and does not involve a change of use, tree removal, clearance of woodland habitat, new buildings, or the creation of additional access land. No significant new hardstanding or other works affecting habitat are proposed. Accordingly, the proposal does not impact an onsite priority habitat and the development site is below 0.2 hectares. The applicant therefore considers that the general Biodiversity Gain Condition does not apply.
