Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 – Mature Willow. Proposed works:

I propose to re-pollard the Weeping Willow Tree, reducing the height and lateral spread. Dead, damaged and crossing branches will also be removed where appropriate.

All works will be undertaken by a suitably qualified and insured arboricultural contractor and in accordance with BS 3998:2010 – Tree Work: Recommendations.

Reason for proposed works:

I have been contacted by consultants acting on behalf of the buildings insurer of the adjoining property (Number 56) in connection with a subsidence claim at that property.

Those consultants have advised me that investigations undertaken on behalf of the insurer have identified roots which they attribute to T1 within soil beneath the adjoining property's foundations. Their recommendation is for the complete removal of T1.

I wish to retain this mature willow and its amenity value within the Conservation Area and do not wish to remove the tree.

I have verbally agreed with Michelle Bleasdale at Davies Group Ltd (The Consultants), without accepting liability or responsibility for the alleged damage, or accepting the conclusions as to causation or the necessity for removal, the above pollarding as a reasonable and precautionary tree-management measure and as a proportionate alternative to the complete removal requested by the adjoining property's insurer's consultants.

The proposed works are intended to reduce the water uptake of the tree from the clay substrate, whilst retaining the tree in a healthy, balanced and sustainable form.

The correspondence received from the insurer's consultants, together with the relevant arboricultural/root identification information and site plan, is provided for background information only.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
