Both have deep cracks in their trunks which can be viewed in the attached photographs - T1 pics and T2 pics.

The canopy of both trees are sparse due to die back and are also small in relation to their height.

T1 has been hit by lightning and has honey fungus the trunk is also hollow.

T2 is leaning and has lots of epicormic shoots coming from the base which shows the tree is in distress and it is also being crowded out by surrounding trees.

We would like to apply to remove both Trees as they appear dangerous and could cause significant damage if they were to fall.

Our tree surgeon (Able Tree Surgeons - Paul Howarth 07814 763509) has described the trees as dangerous and that they need to be removed.

Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

In the attached file Tree App 2026 you will see Trees marked T1 & T2, these are White Beams and both have cracks in their trunks and are showing signs of distress as shown in the attached photographs.

Our tree Surgeon has visited site and in his opinion both need to be felled as they are dangerous.

Therefore we wish to apply to have the Trees professionally felled and removed from site.

Ideally we do not wish to plant any more trees in our garden as we feel we already have a sufficient number.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
