## **SPEED LIMITS**

1. No person shall drive any motor vehicle at a speed exceeding 30 mph on the lengths of the road specified in the First Schedule

### **REVOCATIONS**

2. The speed limit provisions listed in the Second Schedule shall hereby be revoked to the extent as set out in the Second Schedule

- 3. Except where the context otherwise requires, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order and any reference to a numbered Schedule is a reference to the Schedule bearing that number in this Order.
- 4. Any reference to a Statute or Statutory Instrument in this Order shall include reference to any subsequent Statute or Statutory Instrument where the context requires it.
- 5. This Order shall come into effect on the 16<sup>th</sup> day of February Two Thousand and Twenty four and may be cited as the "Kirklees Council (Speed Limit) (No.117) Order 2022".
