ROAD TRAFFIC REGULATION ACT 1984 – SECTION 23

NOTICE OF PROPOSED CONVERSION OF ZEBRA CROSSINGS TO PUFFIN CROSSINGS AND AMENDMENTS TO THEIR EXTENTS

TOWNGATE, VICTORIA SQUARE AND VICTORIA STREET, HOLMFIRTH

NOTICE IS HEREBY GIVEN that Kirklees Council propose to carry out under Section 23 of the Road Traffic Regulation Act 1984, as amended, the following works at the following locations:

1. **Conversion of existing Zebra Crossing to Puffin Crossing and amendment of extents on VICTORIA STREET, Holmfirth:** the centre point of which is located 1.5 metres north-west of its junction with Hollowgate: -
 - (a) the south-west side of, located from a point 2 metres north-west of its junction with Hollowgate (north-westward 18 metres) to a point 0.5 metres north-west of the south-eastern most boundary wall of No. 11 Victoria Street;
 - (b) the north-east side of, located from a point 75 metres south-east of its junction with Huddersfield Road (south-westward 21 metres) to its junction with Towngate.

2. **Conversion of existing Zebra Crossing to Puffin Crossing and amendment of extents on TOWNGATE, Holmfirth:** the centre point of which is located 1.5 metres north-east of its junction with Dunford Road: -
 - (a) the north-west side of, located from its junction with Victoria Square to a point 2.5 metres north-east of a point opposite the southern building line of Holy Trinity Church, Towngate (north-eastward 16.5 metres);
 - (b) the south-east side of, located from a point 14 metres south-west of the point in line with the southern building line of Holy Trinity Church, Towngate south-westward to its junction with Dunford Road (south-westward 18 metres).
