KIRKLEES COUNCIL (TRAFFIC REGULATION) (No. 02) ORDER 2023

VARIOUS ROADS IN THE LOCKWOOD AREA

The Council of the Borough of Kirklees have made the above Order under their powers in the Road Traffic Regulation Act 1984 the effect of which, as it affects lengths of road in Lockwood, Huddersfield in the Kirklees district, will be as follows:-

1. To prohibit the waiting of vehicles at any time on the following lengths of road:

- i. <u>Albert Street, Lockwood, Huddersfield</u>
- a) South-east side from its junction with Bridge Street for a distance of 21 metres in a north-easterly direction
- b) North-west side from its junction with Bath Street to its junction with Fair Street
- c) North-west side from its junction with Fair Street to its junction with Summer Street
- d) North-west side from its junction with Summer Street to its junction with Victoria Street
- e) North-west side from its junction with Victoria Street to its junction with Logwood Street
- North-west side from its junction with Logwood Street to its junction with Lockwood Road
- g) North-west side from its junction with Crowther Street to its junction with Albert Street Link Road
- h) North-west side from its junction with Crowther Street to its junction with Bath Street
- i) West side from its junction with Lockwood Road for a distance of 85 metres in a south and south-westerly direction
- j) South-east side from a point 130 metres north-east of its junction with Bridge Street for a distance of 106 metres in a north-easterly direction
- k) East side from its junction with Lockwood Road for a distance of 44 metres in a southerly direction
- ii. <u>Bath Street, Lockwood, Huddersfield</u>

Both sides from its junction with Lockwood Road for a distance of 5 metres in a south-easterly direction

- iii. <u>Bridge Street, Lockwood, Huddersfield</u>
- a) North-east side from its junction with Lockwood Road to its junction with Albert Street
- b) North-east side from its junction with Albert Street for a distance of 16 metres in a southerly direction
- c) South-west side from its junction with Meltham Road for a distance of 27 metres in a south-easterly direction
- d) South-west side from its junction with Brewery Drive for a distance of 16 metres in a north-westerly direction

iv. Crowther Street, Lockwood, Huddersfield

- a) North-east side from its junction with Albert Street for a distance of 3 metres in a north-westerly direction
- b) North-east side from a point 20 metres north-west of its junction with Albert Street for a distance of 7 metres in a north-westerly direction
- c) South-west side from its junction with Albert Street for a distance of 2 metres in a north-westerly direction
- South-west side from a point 17 metres north-west of its junction with Albert Street for a distance of 17 metres in a north-westerly direction then across end of road to opposite kerb

v. Fair Street, Lockwood, Huddersfield

South-west side from its junction with Albert Street to its junction with Lockwood Road

vi. <u>Lockwood Road, Lockwood, Huddersfield</u>

- North-west side from its junction with Swan Lane for a distance of 53 metres in a north-easterly direction
- b) North-west side from its junction with Mount Street for a distance of 32 metres in a north-easterly direction
- c) North-west side from a point 44 metres south-west of its junction with Mount Street for a distance of 22 metres in a south-westerly direction
- d) North-west side from its junction with Mount Street for a distance of 21 metres in a south-westerly direction
- e) North-west side from its junction with Mount Pleasant for a distance of 14 metres in a south-westerly direction
- North-west side from its junction with Mount Pleasant for a distance of 16 metres in a north-easterly direction
- g) South-east side from its junction with Fair Street to its junction with Bath Street
- h) South-east side from its junction with Summer Street to its junction with Fair Street
- South-east side from its junction with Albert Street for a distance of 19 metres in a south-westerly direction
- j) South-east side from its junction with Bath Street to its junction with Albert Street
- k) South-east side from the projected north-eastern kerbline of the junction with Summer Street for a distance of 5 metres in a north-easterly direction

vii. Meltham Road, Lockwood, Huddersfield

- a) North-west side from its junction with Swan Lane to its junction with Neale Road
- b) South-east side from its junction with Bridge Street for a distance of 39 metres in a south-westerly direction

viii. Mount Street, Lockwood, Huddersfield

Both sides from its junction with Lockwood Road for a distance of 6 metres in a north-westerly direction

ix. Neale Road, Lockwood, Huddersfield

South-east side from its junction with Swan Lane for a distance of 3 metres in a south-westerly direction

x. <u>Summer Street, Lockwood, Huddersfield</u>

- a) North-east side from its junction with Lockwood Road for a distance of 40 metres in a south-easterly direction
- b) South-west side from its junction with Lockwood Road for a distance of 3 metres in a south-easterly direction

xi. Swan Lane, Lockwood, Huddersfield

- a) North-east side from its junction with Lockwood Road for a distance of 51 metres in a north-westerly direction
- b) South-west side from its junction with Meltham Road for a distance of 43 metres in a north-westerly direction
- c) South-west side from its junction with Neale Road for a distance of 4 metres in a south-easterly direction
- 2. To prohibit the waiting of vehicles at an time and to prohibit the loading and unloading of vehicles between the hours of 7:30am 9:30am and 4pm 6:30pm, Monday to Friday on the following lengths of road:-
- i. Albert Street, Lockwood, Huddersfield
- a) North-west side from its junction with Bridge Street for a distance of 49 metres in a north-easterly direction
- b) South-east side from a point 21 metres north-east of its junction with Bridge Street for a distance of 109 metres in a north-easterly direction
- ii. Lockwood, Road, Lockwood, Huddersfield
- a) North-west side from a point 53 metres north-east of its junction with Swan Lane for a distance of 131 metres in a north-easterly direction
- b) South-east side from its junction with Bridge Street for a distance of 103 metres in a north-easterly direction (Loading and unloading of vehicles prohibited between the hours of 4pm 6:30pm only)
- 3. To prohibit the waiting and loading and unloading of vehicles between the hours of 7:30am 9:30am and 4pm 6:30pm, Monday to Friday on the following lengths of road:-
- Albert Street, Lockwood, Huddersfield

North-west side from a point 49 metres north-east of its junction with Bridge Street for a distance of 67 metres in a north-easterly direction

ii. Lockwood Road, Lockwood, Huddersfield

North-west side from a point 21 metres south-west of its junction with Mount Street for a distance of 23 metres in a south-westerly direction

- 4. To limit the waiting of vehicles to 30 minutes with no return within 60 minutes on the following lengths of road (The restriction will apply from 8am to 4pm Monday to Friday):-
- i. Bridge Street, Lockwood, Huddersfield

South-west side from a point 27 metres south-east of its junction with Meltham Road for a distance of 16 metres in a south-easterly direction

ii. Lockwood, Road, Lockwood, Huddersfield

South-east side from a point 19 metres south-west of its junction with Albert Street for a distance of 42 metres in a south-westerly direction

5. To introduce designated electric vehicle charging places on the following length of road (with waiting limited to 3 hours and no return within 3 hours):

Crowther Street, Lockwood, Huddersfield

South-west side from a point 2 metres north-west of its junction with Albert Street for a distance of 7.5 metres in a north-westerly direction

6. To revoke certain items in the Kirklees Council (Traffic Regulation) (Huddersfield Area) (Consolidation) Order 2017 which will be redundant when certain of the restrictions referred to above are introduced
