

**KIRKLEES COUNCIL  
(TRAFFIC REGULATION) (NO.24) ORDER 2021  
BOBBIN CLOSE AND MANOR ROAD, GOLCAR, HUDDERSFIELD**

The Council of the Borough of Kirklees propose to make the above Order under their powers in the Road Traffic Regulation Act 1984 the effect of which, as it affects lengths of road in the Huddersfield area of the Kirklees district, will be to:

**(i) Prohibit the loading and unloading of vehicles during the times and days specified on the following lengths of road:-**

1. Bobbin Close, Golcar, Huddersfield

On both sides from a point 4 metres from its junction with Manor Road for its entire length.

Monday to Friday, between 8:00am to 9:30am and 14:30pm to 16:00pm

2. Manor Road, Golcar, Huddersfield

On its South-west side from its junction with Bobbin Close for a distance of 11 metres in a south-easterly direction and across end of Manor Road

Monday to Friday, between 8:00am to 9:30am and 14:30pm to 16:00pm

**(ii) Prohibit the waiting, loading and unloading of vehicles during the times and days specified on the following lengths of road marked with "School Keep Clear" markings:-**

1. Bobbin Close, Golcar, Huddersfield

On its North-west side from its junction with Manor Road for a distance of 4 metres in a south-westerly direction

Monday to Friday, between 8:00am to 9:30am and 14:30pm to 16:00pm, on entrance markings

2. Manor Road, Golcar, Huddersfield

a) On its North-east side from a point 105 metres south-east of its junction with Access To Rear Of 82-98 Manor Road for a distance of 32 metres in a south-easterly direction

b) On its South-west side from its junction with Bobbin Close for a distance of 28 metres in a north-westerly direction

Monday to Friday, between 8:00am to 9:30am and 14:30pm to 16:00pm, on entrance markings

**REASON:** After working with Golcar Junior, Infant and Nursery School on parking and safety issues around school start and finish times on Manor Road, it is proposed to introduce some additional school keep clears and some “no waiting Monday to Friday between 8am and 9.30am and 2.30pm and 4.00pm” restrictions in the adjacent cul-de-sac Bobbin Close:

- Manor Road - To remove parking from the end of Manor Road to allow pedestrians clear access to the pedestrian link to Church Street
- Bobbin Close - To prevent parking displaced by additional school keep clears from moving to Bobbin Close as an alternative place to park

It is intended these proposals will improve highway safety for pedestrians and other non-motorised users in this location.
