

**KIRKLEES COUNCIL  
(TRAFFIC REGULATION) (NO.32) ORDER 2021  
CUMBERWORTH ROAD, BEDALE AVENUE, GARDENERS WALK, HEATHER FOLD AND  
WESTFIELD AVENUE, SKELMANTHORPE**

The Council of the Borough of Kirklees propose to make the above Order under their powers in the Road Traffic Regulation Act 1984 the effect of which, as it affects lengths of road in the Skelmanthorpe area of the Kirklees district, will be to:

**(i) Prohibit the waiting at any time on the following lengths of road:-**

1. Bedale Avenue, Skelmanthorpe

- a) On its north-east side from its junction with Cumberworth Road for a distance of 12 metres in a north-westerly direction
- b) On its south-west side from its junction with Cumberworth Road for a distance of 13 metres in a north-westerly direction

2. Cumberworth Road, Skelmanthorpe

- a) On its north-west side from its junction with Gardeners Walk for a distance of 10 metres in a south-westerly direction
- b) On its north-west side from its junction with Heather Fold to its junction with Bedale Avenue
- c) On its north-west side from its junction with Bedale Avenue for a distance of 13 metres in a south-westerly direction
- d) On its north-west side from its junction with Heather Fold for a distance of 12 metres in a north-easterly direction
- e) On its north-west side from its junction with Gardeners Walk for a distance of 10 metres in a north-easterly direction
- f) On its south-east side from its junction with Westfield Avenue to the boundary of Nos. 35/37
- g) On its south-east side from its junction with Westfield Avenue for a distance of 10 metres in a south-westerly direction

3. Gardeners Walk, Skelmanthorpe

On both sides from its junction with Cumberworth Road for a distance of 10 metres in a north-westerly direction

4. Heather Fold, Skelmanthorpe

- a) On its north-east side from its junction with Cumberworth Road for a distance of 13 metres in a north-westerly direction
- b) On its South-west side from its junction with Cumberworth Road for a distance of 15 metres in a north-westerly direction

5. Westfield Avenue, Skelmanthorpe

On both sides from its junction with Cumberworth Road for a distance of 10 metres in a south-easterly direction

**REASON:** Concerns were raised about vehicles parking too close to the junction causing visibility issues for vehicles exiting Heather Fold.

To prevent parking at this junction it is proposed to install “no waiting at any time” restrictions here and at key locations along this section of Cumberworth Road. This will also include the junction of Bedale Avenue, Gardeners Walk and Westfield Avenue to prevent the displacement of vehicles to these locations.

It is intended these proposals will improve highway safety for all road users.
